MONDAY, MAY 23, 2015 ²⁰¹⁶

Status conference for approval by the Court of proposed additional questions to be included with Juror Questionnaire, and to discuss pretrial motions and schedule for hearing motions. The conference will be held at 9:30 am at the Charleston County Courthouse or by teleconference call at the discretion of the Court.

FRIDAY, JUNE 3, 2015 ²⁰¹⁶ *gn*

Opposing counsel shall respond in writing to all briefs filed in support of pretrial motions or the moving parties motion is considered stipulated to.

THURSDAY, JUNE 23, 2016 AND FRIDAY, JUNE 24, 2016

Final hearing dates for all pending pre-trial motions previously filed in this matter. Hearing will begin at 9:30 am each day at the Charleston County Courthouse.

FRIDAY JULY 8, 2016

The State and Defense shall be prepared to stipulate by agreement as to those exhibits to be introduced at trial by the parties, if no objection on said exhibits.

FRIDAY JULY 8, 2016

Attorneys provide witness list to the Court. Conference to review Juror Questionnaires and excusal of jurors eligible by statute. Conference to begin at 10:00 am at Charleston County Courthouse.

MONDAY, JULY 11, 2016

Jury panel arrives at Charleston County Courthouse at 10:00 am. Qualification process begins.
